- September 11, 2014
- Recommended customers upgrade by October 1, 2014
 - ➤ "HUD expects all CoC's to begin using HMIS with the elements contained in these standards on October 1, 2014" 2014 DD

2014 Data Dictionary

The document has been divided into several "parts"

- This division gives HUD and the other Federal Partners the ability to make revisions as needed without going through the whole legal process
 - > 2014 HMIS Data Dictionary Vendors
 - > 2014 HMIS Data Standards Manual CoCs/Sys Admins/Users
 - Individual Program Manuals
 - > HUD, HHS, VA (all pending release this fall)





HMIS is meant to record client-level information about numbers and needs of persons using housing and services:

- New format for each element
- Language changes
 - Program = Federal, State, Local Funding Sources (ESG, HOPWA)
 - Project = Refers to the work being done (Emergency Shelter, RRH)
- Charts provided in the DD with information about which programs collect what data for reporting
- Various picklist/wording changes throughout
- Element types
 - Project Descriptor Data Elements
 - Universal Data Elements
 - Program Specific Data Elements
 - Metadata Elements (New)

Better Defined Data Collection Stages:

- Record Creation
- Project Entry
- Update
 - Multiple "updates" allowable
 - ServicePoint Functionality = Interim Review REQUIRED
 - Picklist value of "Update" added
- Annual Assessment
 - Must occur at least once annually (max 1x per year) for clients enrolled 365+ days and must occur +/- 30 days from Client's Anniversary Date
 - ServicePoint Functionality = Interim Review REQUIRED
 - Picklist value of "Annual Assessment" added
- Project Exit







Project Descriptors – Section 2

These Elements identify the organization and project with specific details to help facilitate reporting:

- Organization Identifiers
- Project Identifiers
- Continuum of Care Code
- Project Type
- Method for Tracking Emergency Shelter Utilization
- Federal Partner Funding Sources
- Bed and Unit Inventory
- Site Information (Optional)
- Target Population (Optional)







Project Descriptors – Section 2

Critical Elements for Accurate Reporting:

- Continuum of Care Code
 - > A Project may now be listed as operating in one or more CoCs
 - This field will be used for things like System Performance Measures and in other HUD/Federal Partner Reporting
- Project Type
 - Each project can have only ONE Project Type
 - If a particular agency has a project that performs more than one activity, more than one project must be set up
- Method for Tracking Emergency Shelter Utilization
 - Projects are either Entry/Exit or Night-by-Night
 - Performance will be measured based on the selection







Universal Data Elements – Section 3 These Elements are required for all HMIS participation of the continuum projects: These Elements are required for all HMIS participating continuum projects:

- **New Elements**
 - Destination
 - Relationship to Head of Household
 - Client Location Code
 - Length of Time on Street, in an Emergency Shelter, or Safe Haven
- Removed Elements
 - Zip Code of Last Permanent Address
 - Now collected as part of Last Permanent Address for SSVF program only
 - **Housing Status**
 - Now a Program Specific Element (collected at Entry only for PATH, RHSAP) and HOPWA)



Universal Data Elements – Section 3 Full list of 2014 UDEs: Name

- Social Security Number
- Date of Birth
- Race; Ethnicity
- Gender
- Veteran status
- **Disabling Condition**
- Residence Prior to Project Entry/Length of stay in previous place
- Project Entry Date; Project Exit Date
- **Destination**
- Personal ID; Household ID
- Relationship to Head of Household
- **Client Location Code**
- Length of Time on Street, in an ES or SH







Universal Data Elements — Section 3 Summary of Changes: ➤ Name

- - Adds Name Data Quality
- > SSN
 - Adds DQ picklist value for Approximate or Partial SSN
- > DOB
 - Adds request to approximate DOB if the year of birth can be pinpointed to a year. IE 34 years old (1980) should be entered as 1/1/1980 (Approximate)
- Race
 - ServicePoint displays Primary and Secondary but options available for races 3-5







Universal Data Elements – Section 3 Summary of Changes: Gender

- - Adds Text box for "Other"
- Veteran Status
 - Location of Element is changed, now found on Client Table this allows value to "Carry Forward" from Project Entry to Project Entry
 - Record as Yes for any client who has been Active Duty in the Armed **Forces**
- Disabling Condition
 - Required only for Adults
 - Independent of Disability Type but if a Disability Type is indicated, needs to be marked Yes







Universal Data Elements – Section 3 Summary of Changes: Relationship to Head of Household

- - A household is a group of people who apply for services/housing together
 - Only one client per Household can be marked "Self"
 - If there is a single person, mark as "Self"
 - There is no tie between this new Dynamic Question and the Household Tab
- **Client Location**
 - Location of Client for Residential Stay or Services
 - Uses values from CoC Code selected in Project Set up







Universal Data Elements – Section 3 Summary of Changes:

- Length of Time on Streets, in an Emergency Shelter or Safe Haven:
 - There is not a single question for this data element it is a series of several different questions
 - This does NOT include time spend in a Transitional Housing project
 - Values from this response (along with Disability information) will be used to determine Chronic Homeless status
 - > 1 day of homelessness in a month = 1 month of homelessness
 - Status documented refers to ability to document the length of homelessness (HMIS, outreach statement, etc).







These elements provide information about the characteristics of clients, services provided and outcomes

These elements are combined with the UDEs into 18 new assessments to facilitate data collection and reporting

- > PATH
- > SSVF, VASH
- > RHSAP
- > RHY
- > HOPWA
- Annual Assessment
- Note: Only these new assessments will be updated with new questions

- Path Status
- Connection with SOAR
- Additional questions about Mental Health Problem
- Additional question about Substance Abuse

- Veteran's Information
- Percent of AMI
- Last Permanent Address (Prior to Entry)

Required for HOPWA only:

Medical Assistance

Required for RHSP only:

Worst Housing Situation







Required for RHY only:

- RHY-BCP Shelter Status
- Sexual Orientation
- Last Grade Completed, School Status
- Employment, Health, Dental, Mental Health Status
- Formerly a Ward of Child Welfare/Juvenille Justice System
- Young Person's Critical Issues
- Referral Source
- Commercial Sexual Exploitation

- Transitional, Exit-Care or Aftercare Plan and Actions
- Project Completion Status
- Family Reunification Achieved







Metadata Elements – Section 5

These are Elements which contain "data about data" and are new to the Data Dictionary:

- Date Created
- Date Updated
- Data Collection Stage
 - Update and Annual Assessment added to Interim Reviews
- Information Date
- Project Identifier
- Project Entry Id
- User Id







Administrative Changes

Update Project Descriptor Data Elements

- New/Revised elements found on the HUD Standards Tab
- > Elements no longer required are marked (Retired); these are retained for historical purposes

CoC Code Sub-Assessment (New)

Create picklist for this element in Picklist Admin

Non-HUD elements required on the HUD Standards Tab

- Provider Grant Type
- Service Transaction Workflow (non-HUD/FP funded only)

Set Assessments, Services quicklist, Referrals







Workflow Changes

HUD Verification for Sub-Assessments

- All responses can be entered using the existing workflow or by clicking on the HUD Verification hyperlink
- Income, NCB, Disability, and Health Insurance new required step to mark all non-Yes picklist values with No, Null or Client Doesn't Know, Client Refused

All HUD/Federal Partner funded projects must use Interim and Follow **Up Review**

- Interim Reviews are required to record "Updates" and "Annual Assessment"
- Workflow is available on Collaborango

All HUD/Federal Partner funded projects must use Entry/Exits

Includes ESG funded projects for Prevention and Emergency Shelter

Projects using Services Transaction Workflow enter "Destination" field in Service Transactions

Connecting Communities > Demonstrating Outcomes™



Workflow Changes (cont.)

SSVF, PATH, HOPWA, RHY projects will select Service Transaction Type, Referral Type (as applicable) prior to selecting AIRS code

- > Triggered by appropriate Provider Grant Type setting on HUD Standards tab
- Additional questions required for services based on program

PATH Projects will have a new workflow

- Workflow document available on Collaborango
- Start new workflow after scripting is complete

HUD will issue additional guidance on report changes etc.

- New version of Transition APR (minor changes) released end of September 2014
- > ESG CAPER specifications released, minor changes pending
- ➤ AHAR No changes for 2013-2014 year; new AHAR next year
- PATH Transition Report specifications released, minor changes pending
- Other "canned" reports and ReportWriter updated; HUD 40118 Report removed
